The 2022 five-day/four night camp sessions took place in two locations: near Atlanta, Georgia (Camp Twin Lakes in Rutledge, GA) and in Western North Carolina (YMCA Camp Harrison in Boomer, NC). Camps were leased for one-week programs in March and October. The website is maintained for camper sign-up and for recruitment of volunteers. There is extensive planning for camp sessions for adults with developmental disabilities. The Williams syndrome camp session was held March 7-11, 2022 and served 30 adults with Williams syndrome with help from 32 volunteers. A second camp session in Georgia was held March 14-18, 2022 and served 41 disabled adults with help from 45 volunteers. The first North Carolina session was held October 1-5, 2022 and served 51 disabled adults with help from 47 volunteers. The second NC session was held October 8-12, 2022 and served 53 disabled adults with help from 46 volunteers.
